The FCM will contact you to discuss your child and to help determine if residential placement may be appropriate. If our program is not suitable to meet your child's needs, the FCM will provide you with a list of resources that may be more appropriate. During the application process you will be asked to provide access to educational, medical, and any behavioral health records. If your child reaches the interview stage of the process, your local Sheriff will be notified that a youth from their county is being interviewed for potential placement with the Florida Sheriffs Youth Ranches. The final decision rests with the program's admission committee. If your child is accepted, the FCM and program staff will coordinate placement into residential care.
